GFA – Beyond Overseas Development Assistance

Since its foundation in 1982, GFA has successfully pursued its vision to become the partner of choice for major Overseas Development Assistance (ODA) agencies. In this context, GFA's core business has been multi-faceted development project management in more than 130 countries. Numerous new approaches and instruments have been developed in a variety of sociocultural settings, and many lessons learnt have been drawn. Yet, the methodological and management expertise gained was sparsely applied to projects and programs at GFA's doorstep in Germany. But GFA soon became a trendsetter when policy makers realized this valuable potential. Some cases in point may illustrate this development.

Microcredit schemes turned into an established poverty alleviation instrument in development cooperation. Since mid 2010, GFA has grown to be a leading microfinance provider in Germany when it launched its OPTIMIST program for small and micro enterprises in Germany, an initiative supported by the German Ministry for Labor and Social Affairs. Impact monitoring of social programs is essential in development cooperation to justify international aid financed by tax payers. Tremendous efforts were made in development cooperation to measure budget impacts while policy makers in

industrialized countries were mostly concerned about budget spending. But this is changing rapidly due to dwindling public coffers. Measuring impacts of public investments has become a popular demand by policy makers and the electorate. Consequently, GFA Consulting Group increased efforts advising Europe-Aid in further refining its impact monitoring instruments for ODA purposes. GFA Public in Berlin, inter alia, provides research and management assistance to public sector agencies trying hard to assess the impacts of labor and other social programs. The implementation of private sector development projects worldwide has helped GFA acquire vast expertise in promoting products and services of key economic sectors of developing or transition countries. In recent years, GFA was able to extend this knowhow to key industries of the German economy. For example, GFA implements a Ministry of Agriculture (BMELV) program which promotes German agro industry investments in developing and transformation countries. GFA is also seconding staff to the Ministry of Economics and Technology to assist export promotion efforts of German industries related to energy efficiency and renewable energies worldwide.

From TRANSFORM to Private Public Partnerships

Since 1993, the Federal Ministry of Food, Agriculture and Consumer Protection (BMELV) awarded GFA a general mandate within the framework of the former TRANSFORM and its current Bilateral Cooperation Program. GFA developed and implemented hundreds of projects totaling 80 million Euros.

In the beginning, the overarching issue was support for the agriculture and food industries in Central and Eastern European countries to aid them in the transition from a planned command economy to market economy structures and processes. Even then, it was clear that the partners were not conventional developing countries' recipients so that the projects' methods and instruments had to be managed accordingly.

New Trends

Over the years, the program's thematic and geographical focus has changed while private sector co-financing of projects increased. GFA facilitated this process by developing a program concept that provides optimal opportunities for a rewarding cooperation of German companies with partners in these emerging nations. Today, the program combines government consulting projects, so called agricultural policy dialogues, with hands-on projects in the field. Policy dialog harmonizes partner countries' and EU standards, improves market access for Ger-

man companies, and supports bilateral trade in Russia, Ukraine and Kazakhstan. Hands-on projects focus on consulting services, knowledge transfer and training. GFA initiates and supports twinning arrangements of German organizations with similar institutions in partner countries, e.g. between German and Russian farmers associations or between universities. This promotes knowhow transfer and helps the German agricultural and food industry take advantage of foreign market opportunities.

Future Prospects

In order to tailor projects even closer to interests of German and partner countries' enterprises, GFA started developing additional public private partnership (PPP) concepts, and adapted politics, sectors and methods in what are called economic cooperation (WKO) projects. From scratch, strategies are planned and executed together with German companies and associations in the agriculture and food sector. Enterprises and government contribute their share to reach common goals, inclusive joint financing of projects. While the focus on emerging nations remains a brand mark of GFA's work for BMELV, the program is open for projects worldwide since 2008. New regional activities encompass China, Kazakhstan, Romania/Bulgaria, Brazil and Turkey. GFA currently investigates the potential of further projects in India, Mongolia, Uzbekistan, Serbia, Croatia, Chile and Morocco.

FEA supports vocational programs

BERUFSSTART plus (start on the job), a program of the Federal Employment Agency (FEA) in Nürnberg, prepares students of comprehensive schools in Thuringia for vocational training. Students at grades 7-10 will develop their own professional orientation, test occupations and improve their vocational skills. GFA Public, in cooperation with the Centre for European Economic Research, started evaluating this program in August 2010 and will complete its assessment in September 2012. The evaluation should establish whether the program meets the impact indicators monitored and improves students' professional orientation. GFA will also analyze whether the program can be made an FEA service and can be adapted to other regions. Methodologically, the research project is based on three elements:

Implementation analysis will assess the implementation of BERUFSSTART plus by various actors as far as concept and financing, the selection of schools, educational providers and students as well as further activities at participating schools are concerned. GFA will conduct qualitative case studies at 25 sites, inclusive document analyses and interviews with participating teaching staff and students. Impact analysis aims at a quantitative review of the program's causal effects on students who engage in program activities, and will use panel interviews. Site analysis, based on available statistical data, will look into regional or school related factors that influence the program's acknowledged impacts.

The Optimists

The Hamburger Abendblatt recently portrayed the mode of operation of a new GFA corporate unit, GFA Mikrokredit. The bottom line: "Development assistance comes home to Germany". This optimistic and innovative conclusion refers to GFA's special microcredit program called "OPTIMIST – Der Mikrokredit" that offers access to loans to small enterprises in Northern Germany which are rated 'not creditworthy' with banks.

Loans up to 10,000 Euros are granted at an interest rate of 7.5%, to be repaid within 24 months. In this context, GFA's Financial Systems Development Department applies experiences gained with numerous microfinance projects and their

positive impact on improved economic conditions worldwide. The funds, allocated by the Federal Ministries for Social Affairs and Labor as well as Economics and Technology, are disbursed by the GLS Bank eG and supervised by the German Microfinance Institute (DMI). After just three months in operation, GFA has 35 loans amounting to 220.000 Euros confirmed, 29% to women and 37% to applicants with a migration background. A plumber, a carpenter, an architect, and the owners of a nail studio and a samba school are typical entrepreneurs in need of investment capital.
