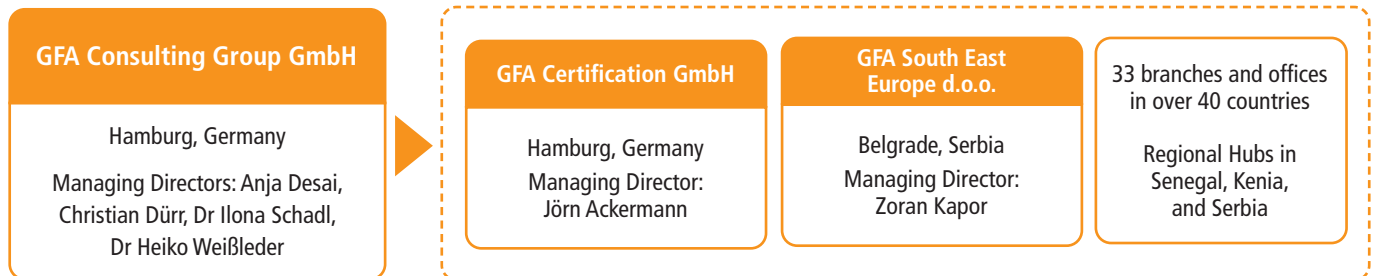


GFA IN BRIEF

GFA'S STRATEGIC BUSINESS AREAS

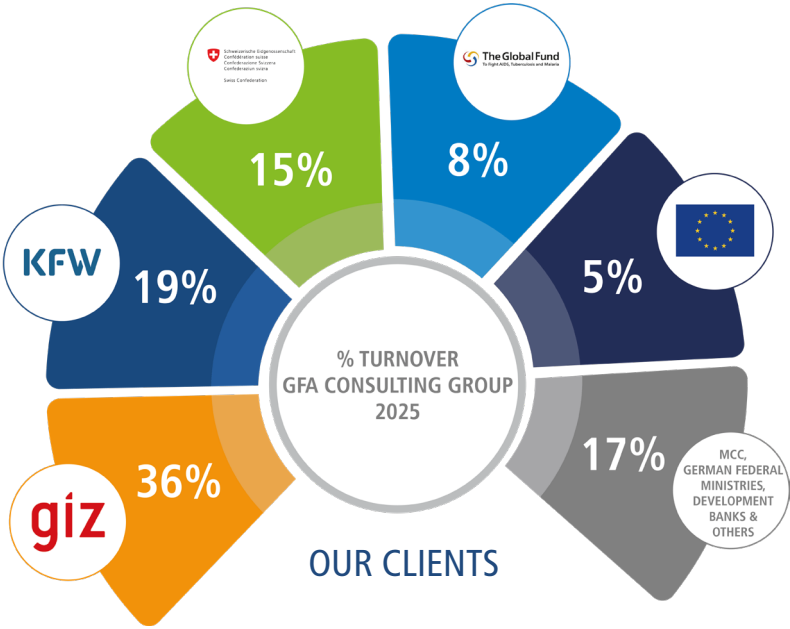


Aspects relating to monitoring and evaluation, migration and displacement, and gender and diversity form an integral part of most of the topics and projects in which GFA is involved.
