#### **EDITORIAL**

The German-Zambian Development Cooperation through its "Civil Society Participation Programme", implemented by the "Gesellschaft für Internationale Zusammenarbeit" (GIZ) on behalf of the German Federal Ministry for Economic Cooperation and Development (BMZ) supports Zambia's civil society actors in their call for greater transparency and accountability in public institutions. The 3rd action area of the Programme focused on constructive dialogue at local level and was implemented by GFA Consulting Group as from 2018.

In this context, GIZ CSPP supported CSOs in North-Western, Copperbelt and Southern Provinces to act as intermediaries between the public and the local authorities. As a pilot programme, GIZ CSPP operated in Choma, Monze and Livingstone (Southern Province), Kitwe, Ndola and Mufulira (Copperbelt Province) and Solwezi, Kalumbila and Mushindamo (North-Western Province). The CSOs encouraged municipal information sharing, constructive discussions and the improvement of services by providing needs-based citizen input into local activity plans. In many cases, the CSO's effective advocacy work in local decision-making was demonstrated.

The supported CSOs were both provincial and local CSOs, some operating as branch of national CSOs listed per province separately. Their means of service provision on behalf of GIZ CSPP was the implementation of over 800 community meetings, over 300 stakeholder meetings, over 600 radio shows, 10 procurement projects, 12 events, 16 workshops and 28 trainings always linking citizens to the local authorities and vice versa.

## **ANTI-VOTER APATHY PROJECT**

#### **BRIEF HISTORY**

Anti-Voter Apathy Project (AVAP) was established in Lusaka in 1995 to enhance citizen participation in governance with a strategic goal of increasing the capacities of citizens and reduce apathy in democratic and development processes through training and creative dissemination and sharing of information and knowledge at all levels of governance.

#### **FOUNDED**

The founders of the organisation were teachers who saw the need to promote citizen participation in democratic governance and the electoral process.

#### **MISSION**

To contribute to Zambia's socio-economic, political and democratic development processes through empowerment of citizens with information, skills and knowledge for their effective participation in governance related issues.

#### **AREA OF EXPERTISE**

- Promoting citizens' participation in the electoral process.
- Building citizens' capacity to demand transparency and accountability of public institutions.
- Civic, human rights and voter education and monitoring the electoral process.
- Advocacy and Lobbying for policy formulation and law reform process.
- Building the capacity of youth in leadership skills.

#### **EXAMPLES OF ACTIVITIES UNDERTAKEN**

- In 2006 and 2011, AVAP built capacity and empowered youth from different political parties in Zambia to contest elections as candidates. Thirteen youth became Councillors while 3 became MPs.
- In 2004 established 22 democracy information centres in nine provinces with the support of GIZ.
- In 2004, partnered with PACT ZAMBIA to implement 9 provincial meetings that led to enhanced parliamentary reforms and establishment of National Assembly offices in different constituencies.
- Promoted transparency and accountability in the management and utilisation of CDF in wards in Luangwa district.
- In 2015 and 2016 with Action Aid, conducted 6 interface meetings in Mulobezi district resulting in the youths being incorporated in the district development planning committee.
- In 2019 and 2020 AVAP received funds from CSPP resulting in the construction of 2 toilets and a borehole at Tuvwanganai market in Solwezi

## **MENTRA YOUTH ZAMBIA**

#### **BRIEF HISTORY**

Mentra Youth Zambia (MYZ) started as a speak-out-program on October 2014. MYZ saw the need and importance of mentorship for young people in Zambia and started helping the youth to realize their potential via participating in governance issues and skills that would positively impact them and bring change to their communities.

#### **FOUNDED**

Born on the basis of passion for the community, MYZ started with two people who shared ideas and created a Facebook page called "Speak Out". Seminars on entrepreneurship and education were organized and talent shows conducted where youths showcased their talent. The activities were championed by Gaharaharashim Mpuhuyawu, Jessica Bwalya and Mwenda Blessings.

#### **AREA OF EXPERTISE**

The group promotes hygiene, communicable diseases prevention and safe learning environments at schools.

#### **EXAMPLES OF ACTIVITIES UNDERTAKEN**

Mentra Youth Zambia has conducted multiple public hearings and stakeholder meetings in 3 districts namely Kalumbila, Mushindamo and Solwezi.

- In Mushindamo District, MYZ focused on people's contribution to Hygiene in public places of Kikola, Kangwena, Mujimanzowvu, Musakaward and Kalilele Wards. It conducted radio shows and promoted COVID-19 prevention and safe learning environments at schools via procurement of desks for pupils in Musaka Ward.
- In Kalumbila District, MYZ focused on people contribution on the modern bus stations in Lumwana Ward;
- In Solwezi district, MYZ procured Hand Washers and Masks for Schools in Solwezi
- MYZ conducted radio shows on "What to do to roads?" covering five wards (Kapijimpanga, Tumvwanganai, Kimasala, Sandangombe and Kamalamba). These programmes involved council officers, Ward Development Committee (WDC) councillors, traditional leaders and CSOs.
- With the support from GIZ CSPP, MYZ handed over 80 desks in 4 schools of Mushindamo district namely; Yowela Primary School, Mushindamo Primary School, Kafulabunga Primary School and Mushindamo Girls Secondary School.

#### **BRIEF HISTORY**

Caritas Solwezi office was established in 1995 at the Catholic Diocese of Solwezi as the Catholic Commissions for Justice, Development and Peace (CCJDP). It comprised of two (2) commissions namely the Catholic Commission for Justice and Peace and the Catholic Commission for Development. Late Bishop Rt. Rev. Abdon Potani founded the Caritas Solwezi.

#### **FOUNDED**

Caritas is a global faith-based organization founded by the Pope after the Second Vatican Council in 1962 with headquarters in Vatican City, Rome, Italy. It is called Caritas Internationalis at that global level while at continental level affiliated as Caritas Africa. Caritas Solwezi covers the whole North Western Province.

### SAVE ENVIRONMENT AND PEOPLE AGENCY

#### **BRIEF HISTORY**

Save Environment and People Agency (SEPA) was founded in 2004 in Zambezi District of Northwestern Province by Mailes Zulu Muke. SEPA is now a member of the AU African Women Innovation Sustainable Environment, SADC Great Wall Initiative and UN Environmental Governing body as an Observer.

#### **MISSION**

Its major focus is to transform rural communities by addressing the adverse effects of climate change, environmental sustainability, food security and promoting agriculture.

#### **AREAS OF EXPERTISE**

- Climate change adaptation and mitigation
- Agriculture promotion and food security
- Promotion of reneweable energy
- Education, child protection and gender equality
- Social accountability
- HIV and AIDS Prevention

#### **EXAMPLES OF ACTIVITIES UNDERTAKEN**

- SEPA facilitated for CSPP community engagement meetings in 5 wards (Lumwana, Mukumbi, Museli, Mwanjimambwe and Shilenda) of Kalumbila District for 10 days under the project "People Contribution to Fighting Climate Change via Tree Planting". A total of 455 participants were involved resulting in community contributions to the AD Plan.
- SEPA through support of GEF/UNDP Small Grants Facility implemented a 2 years project of protecting the international waters (Zambezi River) in Chavuma and Zambezi Districts. The projected sensitised people on the importance of protecting the environment and empowered communities with livelihood activities, such as Conservation farming /gardening, livestock and fish farming.
- SEPA with support from Irish Aid implemented a 2 years project sensitising communities and traditional leaders in 4 chiefdoms on women land rights and natural resources governance in Zambezi District. A total 2,000 people were sensitised through community engagement meetings and drama, while one on one engagement meetings were held with each of the 4 royal establishments. The 4 groups of trained women beekeepers have become agents of change resulting into women being accepted to take up men perceived activities like beekeeping.
- SEPA is implementing a 1 year sensitisation project on women land rights in extractive industry in Zambezi District. The women are also trained in beekeeping & small scale/artisanal mining resulting into 20 women engaging themselves in artisanal mining and 20 in beekeeping.

#### **BRIEF HISTORY**

#### **BRIEF HISTORY**

Zambia Land Alliance — Solwezi (ZLA) is a network of Non-Governmental Organizations (NGOs) working for just land policies and laws that take into account interests of the poor. ZLA operates through a National Office located in Lusaka comprising of eight (8) national member organisations, district branches and project offices.

#### **FOUNDED**

Zambia Land Allinace was established by network organisations in 1997 in Lusaka as a response to the Zambian Government's land reform process, which was initiated in the 1990s.

## MAFKEN FM RADIO LIMITED

#### **BRIEF HISTORY**

Mafken FM Radio is the first ever commercial but still NGO radio station in Mufulira with broadcast coverage across the Copperbelt Province of Zambia. Mafken FM Radio broadcasts on 97.7 MHz in Mufulira and surrounding areas with listenership coverage of about 500,000 people. Mafken is a cosmopolitan radio station that has significantly incorporated women and young adults in its broadcast programming. This programming approach is focused on influencing the widest audience possible in consideration of:

- The key roles that women and young adults play in society.
- The attractive and critical nature of development issues to countries like Zambia.

#### **FOUNDED**

Mafken FM was founded on 5th March, 2018 founded by Edward Mphande a broadcasting enthusiast for the following reason:

- To consistently provide cost-effective and dependable radio media products and services, as well as empower local communities with timely news and essential information.
- To promote education through the direct participation of Mufulira and the Copperbelt residents.
- Promoting regional cultural development and artistic expression with presentations of folk and historical shows.
- Encourage the development of new music appreciation among our listeners with a variety of quality musical programming.
- Offer an initiative news service in order to enlighten the community and favour social and economic regional development.

#### **EXAMPLES OF ACTIVITIES UNDERTAKEN**

Mafken as a platform for information dissemination broadcasted for CSPP a number of radio programs for which several stakeholders were hosted. Among the topics discussed were revenue collection, solid waste management, water and sanitation, information flow between the council and the citizens, sensitization of the community on the formulation of the integrated development plan, and opening of drainages. Other topics included the incidence of the COVID-19 pandemic, the roles of councilors and Ward Development Committees, Community Participation in Integrated Development Plan and Governance. These programs held from 2019 to 2020 were led by senior government, Council officials and other experts as discussants while the public and CSOs actively participated as co-discussants and by phoning in to make their submissions.

As a result of this activity about 1,500 girls were provided with sanitary pads for their menstrual hygiene giving them confidence to attend school regularly. This activity enhanced COVID-19 prevention and also reproductive health information.

The first project was done by volunteers talking to people and distributing IEC materials on COVID-19 prevention methods and by driving around and using a megaphone to disseminate the messages to the communities.
- Both activities changed the communities' mindsets towards the preventive measures within the target areas. As a result, people started wearing face masks, stopped handshakes and started observing social distancing.
- TCCC has contributed to raising awareness on HIV/AIDS in local schools through sensitization, counselling and promoting testing.

- The biggest success for all areas is improved knowledge and enhanced communication between the community and the councils.
- Under COVID-19 sensitisations, 5 community meetings were held in Solwezi
  with business houses and the local council on how they can enforce preventive
  measures. Masks were given out during meetings. The meetings resulted in dispelling myths about the corona virus and replace it with correct information.

- CSPR implemented for CSPP 22 public hearings and community meetings in six wards of the 3 constituencies in Monze District. These meetings discussed various topics among them were the general operations of the local Authority, solid waste management and water affairs in the district. The participation from the communities was overwhelming and as a result, some notable changes have been observed in the operations and service delivery by the council. Noticeably are the increased collection times of garbage, regular holding of community sensitization meetings and the increased uptake of recommendation for consideration in the Council's plan.
- Amid the COVID-19 pandemic, CSPR held financed by CSPP a number of radio programs at Sky FM Radio to sensitise the community about the Corona Virus in conjunction with the Ministry of Health and the local Authority. These activities resulted in the community responding favourable to COVID prevention and safety measures.

#### **BRIEF HISTORY**

The Young Women's Christian Association Zambia (YWCA) was formed in 1957 and operates countrywide. It is a membership, non-partisan, non-governmental organization dedicated to the empowerment of communities, especially women, youth and children for them to realize their potential and to contribute to a just society through rights-based approaches and sustainable interventions.

#### **FOUNDED**

The first YWCA was established in 1855 in England by two groups of women to aid and advance the cause of women. In 1877 they merged and later adopted a constitution in 1884.

#### **MISSION**

Promoting gender equality and ending gender based violence including child marriages, through provision of "temporal, moral, and religious welfare of young women who are dependent on their own exertions for support."

#### **AREAS OF EXPERTISE**

Promoting gender equity and equality, Empowerment of women in all spheres of life, Prevention of gender-based violence and child marriage, and Promoting sexual reproductive health rights.

#### **EXAMPLES OF ACTIVITIES UNDERTAKEN FOR CSPP**

- YWCA Choma in conjunction with Department of Housing and Social Services at Choma Council held 6 community meetings on prevention of gender based violence and early marriages in 3 wards of Kulundana, Simacheche and Mubula. Separate meetings for 663 men and women who participated were conducted over 7 days in a format to allow for free discussions on GBV. These meetings resulted in the Council engaging a legal counsel for the legal department as a GBV focal person.
- YWCA and Chikanta Community Schools Development Project in conjunction with Department of Public Health at Choma Council held water and sanitation consultative meetings in 25 wards of Choma District on boreholes rehabilitation, burying of shallow wells and chlorinating some of the wells. 947 citizens participated and their input resulted in the Council taking action on the issues.
- YWCA in conjunction with Choma District Health Office held COVID-19 Prevention sensitizations for 5 schools in 4 wards of Choma District in December 2020. The activities supported by LoPaGo attracted 246 participants who included parents, teachers, traditional leaders and pupils. Additionally, 34 key stakeholders were introduced to the project at which 50 solar powered radio sets and COVID-19 materials were distributed.

#### **BRIEF HISTORY**

OpenNet4O Zambia started in 2017 as a community based organisation in Choma, Southern Province of Zambia to render a voice to the local people in their quest for a better life.

#### **FOUNDED**

It was co-founded by a young female journalist and energy entrepreneur: Pamela Mutale Kapekele and youth and community development enthusiast, Sipho Mwanza. The organisation was formally incorporated as a Company Limited by Guarantee at PACRA, the following year on February 6, 2018.

#### **MISSION**

- To amplify rural voices by harnessing talents, with a bias towards children, youths and women
- Connecting citizens to opportunities by speaking to power and national processes.
- Promoting educational and sports initiatives.

- OpenNet4O Zambia conducted for CSPP 38 community meetings, in 25 Wards of Choma district from 2019 to early 2021 on the following topics; unplanned settlements, solid waste management, people's contributions to Choma Municipal Council Planning and also engaged vulnerable communities on the COVID-19 pandemic.
- Multiple community consultations involved the local authority and government ministries in which recommendations were made to Choma Municipal Council for consideration and action.
- Some of the successes scored included the Council adopting recommendations from communities on unplanned settlements, especially on occupancy license fees which were reduced from K1050 to K650. Another success is on solid waste management services whose costs and defaulting penalties were reduced while the frequency of collections was increased.
- In 2020, OpenNet4O Zambia planted 4000 trees with assistance from a local company, SWASCO, as part of the environmental clubs in primary and secondary schools across Southern Province. The organization also held the first annual environmental inter-schools quiz for secondary schools in Southern Province.
- In 2020 OpenNet40 Zambia partnered with Irish based Beyond Skin in hosting a culture event on World Peace Day, to show case the Zambia National Dance Troupe and Irish artists.
- The organization also partnered with a UK based True Footprint to develop an App that is used
  to collect COVID-19 data in real time. This was piloted with the blessing of the Ministry of
  Health at three clinics in Choma District in 2020 and is about to be scaled up to other districts.
- A COVID-19 project financed by CSPP also saw 60 school pupils accessing online and radio Ministry of Education learning portals, through smart phones and solar radios that were donated to their schools.

This resulted in participants' submission being recommended for inclusion in the final service charter which has seen some of the pledges being implemented.
